## Invitation for Online Bids

1. Maharajgunj Municipality, Office of Municipal Executive has allocated funds towards the cost of Upgrading and Construction of Road and intends to apply part of the funds to cover eligible payments under the Contract for Maharajganj Sahari bikas Antargat Dhal nikas Tatha sadak Nirman.
2. Bidding is open to all eligible bidders as per Section V of Bidding Document. Maharajgunj Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures (1S2E). Only eligible bidders with the following key qualifications should participate in this bidding:  
**Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 42.00 Million**  
**Minimum Work experience of similar size and nature: NRs. 19.69 Million**  
**Construction Experience in Key Activities: PCC(1:1.5:3): 465 Cum, Premix Carpeting: 98 Cum**
3. Under 1S2E, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at Maharajgunj Municipality, Office of Municipal Executive, Kapilvastu, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).

6. **Sealed or electronic bids must be submitted to the Maharajgunj Municipality, Office of Municipal Executive, Kapilvastu** by through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **18-02-2019 (2075-11-06) 12:00 hours**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **18-02-2019 (2075-11-06) 14:00 hours** at the Maharajgunj Municipality, Office of Municipal Executive, Kapilvastu, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of **NRs.7,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
